Liability Waiver

The undersigned individual agrees to release, acquit, forgive, and discharge Oak Creek Grade Volunteer Fire Department and any/all related Oak Creek Grade Volunteer Fire Department entities and individuals from any actions, claims, demands, suits, agreements, judgments, liabilities, and proceedings, whether arising in equity or in law, and in particular arising from the use of any/all of Oak Creek Grade Volunteer Fire Department related equipment and/or any Activity relating to the Department.

I hereby understand that I have read or received all knowledge, rules, warning, and restrictions of the Activity. I certify that I understand the risks associated with the Activity and agree that I will not hold the Department responsible for any injuries or losses I sustain during the Activity. I agree to release the Department and its Covered Persons and Board from any claims, actions, demands, causes of action, or suits of any kind.

I understand that the Department holds me solely responsible for any damages to myself, others or Department property, if my willful misconduct, negligence, or disregard for the rules of the Activity leads to it.

Assumption of the Risk and Release

I acknowledge that the duties of the Fire Department are inherently dangerous, and am in complete understanding of the risks associated with the Activity, including, but not limited to, the following:

- Broken bones, cuts and bruises, sprained muscles, torn ligaments, back injury, finger injuries
- Brain injury, concussion, skull fracture
- Burns, exposure to fire and smoke, exposure to noxious chemicals
- Infectious illness or disease
- Death

Indemnification

I agree to indemnify, hold harmless, and defend the Department against all causes of action, judgment, claims, damages, property damages, costs, or expenses, including attorney fees and other litigation arising from participating in the Activity. I understand it includes damages, death, or injuries that occur from my use or the use of my family or presence upon the facilities of the Department while participating in the Activity.

No Duress

I acknowledge that I voluntarily consented to the Activity and am under no pressure or duress to sign this **Colorado liability waiver form**. I agree that I have received adequate and reasonable time to review this standard release of liability form.

I acknowledge that I cannot participate in the Activity if I choose not to sign this form. Participation in this Activity is voluntary and I acknowledge that I can withdraw anytime.

This release shall remain binding upon all successors in interest and personal representatives of the contracting parties, to the extent permitted by law.
